



# 2017 Membership Information

*There's a special place not far from your door that makes the rush of the day fade into the background. A place where kids and adults alike can relax, take a swim, play tennis, read a summer novel, work on a tan, talk with friends old and new, barbecue with friends and family, or just sit beneath the blue Carolina sky and tune out the world. Nestled in the trees near the New Irving Park Neighborhood, Lawndale Swim & Tennis Club offers various membership options.*

## **Types of Membership:**

### **Family Membership - \$660**

Family Membership consists of all members of one immediate family residing in one household. It allows all family members the use of the entire facilities including pool, tennis and clubhouse.

### **NEW Family Membership - \$605**

This "trial" membership is available only to first time members for the first year and has the same privileges as Family Swim and Tennis Membership above. This includes \$100 toward Membership Certificate Fee.

### **Family of 2 Membership - \$550**

Family Membership consists of 2 individuals of one immediate family residing in one household. It allows 2 individuals the use of the entire facilities including pool, tennis and clubhouse.

### **Single Membership - \$440**

Single Membership consists of one member only, being an adult (age 18 or older). Membership privileges are the same as Family members described above.

### **Single Tennis Membership - \$220**

Single Membership consists of one member only, being an adult (age 18 or older). It allows the member the full use of the tennis courts and clubhouse.

### **Membership Certificate Fee - \$250**

At this time, Lawndale Swim & Tennis Club is not requiring an initiation fee. All members must, however, purchase a non-refundable membership certificate. Certificate cost is \$250, which can be paid the first year **or** spread over three years at a cost of \$100 per year.

### **Maintenance Fee**

All members are required to pay a maintenance fee or work on cleanup or improvement projects. Numerous workdays will be scheduled throughout the year. The will be added to the total membership dues and the hours credited as they are accumulated. Refunds will be issued for any excess amounts paid.

Single Memberships: \$25 or 2.5 hours

Family Memberships: \$50 or 5 hours

### **Payment Schedule**

Lawndale requires returning members to pay equal monthly installments from November 1<sup>st</sup> to April 1<sup>st</sup>. Members are allowed to pay in full, or to pay the remainder of the dues in full at anytime. If an applicant joins after November 1<sup>st</sup>, then the payments will be made in equal installments for the number of months remaining before April 1<sup>st</sup>. After April 1<sup>st</sup>, the dues must be paid in full. New members joining after July 1st may be eligible to prorate membership dues at the discretion of the board of directors.
