



2019 Lawndale Swim & Tennis Club Membership Information

First Time Membership Discounts: These discounted memberships are available for first time members only.

Family Swim & Tennis (FST): allows all family members residing in a single household use of the entire facilities including pools, tennis courts, and clubhouse. Members are eligible for swim/tennis lessons and teams.

- A. **\$660** This discount includes the first \$100 of the one-time Membership Certificate fee on the 3-year payment schedule plus an extra \$50 off. (Additional \$100 payments to be made during the 2nd and 3rd years of membership.)
- B. **\$810** This new member discount includes the first \$100 toward the full \$250 one-time Membership Certificate fee. (Saves \$50 dollars over 3 years).

Normal Yearly Rate (once purchase of Membership Certificate is complete): **\$710***

Family of Two Swim & Tennis (F2ST): allows two individuals of one immediate family residing in a single household use of the entire facilities including pools, tennis courts, and clubhouse. Eligible for swim/tennis lessons and/or teams.

- A. **\$600** This new member discount includes the first \$100 of the one-time Membership Certificate fee on the 3-year payment schedule. (Additional \$100 payments to be made during the 2nd and 3rd years of membership.)
- B. **\$750** This new member discount includes the first \$100 toward the full \$250 one-time Membership Certificate fee. (Saves \$50 dollars over 3 years).

Normal Yearly Rate (once purchase of Membership Certificate is complete): **\$600***

Single Swim & Tennis Membership (SST): This single person membership allows one member (minimum age 18 years) use of the entire facilities including the pools, tennis courts, and clubhouse. Eligible for swim/tennis lessons and/or teams.

- A. **\$465** This new member discount includes the first \$100 of the one-time Membership Certificate fee on the 3-year payment schedule. (Additional \$100 payments to be made during the 2nd and 3rd years of membership.)
- B. **\$615** This new member discount includes the first \$100 toward the full \$250 one-time Membership Certificate fee. (Saves \$50 dollars over 3 years).

Normal Yearly Rate (once purchase of Membership Certificate is complete): **\$465***

Single Tennis Only Membership (T): This single person membership allows one member who must be at least 18 years old the full use of the tennis courts and clubhouse only. No pool use is included. Eligible for tennis lessons and/or teams.

- A. **\$245** This new member discount includes the first \$100 of the one-time Membership Certificate fee on the 3-year payment schedule. (Additional \$100 payments to be made during the 2nd and 3rd years of membership.)
- B. **\$395** This new member discount includes the first \$100 toward the full \$250 one-time Membership Certificate fee. (Saves \$50 dollars over 3 years).

Normal Yearly Rate (once purchase of Membership Certificate is complete): **\$245***

NEW Dual Club Membership (DST): **\$500** This discounted option is for families who are already full, active members of another local swim club. Membership Certificate and maintenance fees do not apply. Proof of active membership such as a current membership card or paid invoice is required and must be submitted with the membership application. Note that Dual Club members are not eligible for Lawndale swim and/or tennis teams as they are not "active members".

Payment Schedule Lawndale Swim & Tennis dues must be paid in full *by the first day of spring* for Tennis Only members, or *by the opening day of swim season* for all others. Returning members may work out payment plans with our management company. New members joining after July 5th may be eligible for prorated dues at the discretion of the Board of Directors.

Membership Certificate Fee All members are required to purchase a non-refundable Membership Certificate. The one time Certificate Fee is \$250 if paid in full the 1st year or \$300 if spread out over 3 consecutive years at a cost of \$100 per year.

Maintenance Fee *Regular memberships include an annual maintenance fee for which work credit may be earned by participation in club workdays. The maintenance fee for multi-person memberships is \$50, and for single person memberships is \$25. The time required to earn work credit is 5 or 2.5 hours, respectively.

Rules & Regulations All members and their guests shall agree to abide by all rules, regulations, and bylaws of the corporation as set forth by the Board of Directors. Signature on the membership application implies acceptance of these rules.

Guests All guests will be charged a fee of \$5, except for children less than one year of age. Guest fees do not apply to registered family babysitters/nannies. It is the member's responsibility to register all guests or babysitters at the guard house. Discount guest passes are available for purchase at the guard house. Some restrictions apply; see handbook on website for details.

Clubhouse Rentals The clubhouse is available year-round for rental for private events. It is a great space and wonderful location to host an event. The fee for a clubhouse rental is \$50 for members. Pool-side areas may also be rented for parties during swim season. See our website for more details and forms.
